# District Cllr. S. Meghani

Continuing problems emanated from works by Network Plus on behalf of Western Power. Parish Councillors have raised this problem now for well over 2 years which is now outside the 2 years contract liability period.

# Cllr. P Groom

**Follow up from previous meeting on**—Proposal to withdraw Local Council Tax Reduction Scheme Grant to Parish Councils. <a href="https://www.southderbyshire.gov.uk/our-services/council-tax/ctrs">https://www.southderbyshire.gov.uk/our-services/council-tax/ctrs</a> rebate people on benefits get their council taxed paid that affects the number of properties (18 properties) that qualify for Precepts.

Cllr. Groom asked about voting against proposal for zero increase in council tax. Response:-

Cllr Andrew did not agree the alternative budget put forward by the Conservative Group on the District Council, and spoke against it at the meeting, as he felt it was something the Conservative Group only proposed knowing it would grab headlines and not be considered by the ruling Labour Group. He noted that in all the years that the Conservative group had been in control of the Council they had not once put forward anything other than the maximum rise allowed, as they have done at the County Council recently. He and his Lib Dem colleague abstained from the vote on the Labour group rise, as it was not something they had participated in producing.

# Joint report from District Cllrs J Davies and Cllr. G. Andrew

- Cllr Davies is pursuing the SDDC enforcement team regarding the Bus Depot on Woodyard Lane
- Cllr Andrew secured an amendment condition on the recent Planning Application to extend the Dove Valley Business Park to give access to WG Tankers so they will no longer need to use Woodyard Lane.
  Their Planning application is awaited soon.
- Cllr Andrew has escalated the various fly tipping concerns expressed yesterday to the relevant teams.
- Both Cllrs Davies and Andrew continue to chase various other enforcement actions in the area including the Mill Green.
- Local Government reorganisation special meeting of the District Council next week to discuss the Labour groups response (no direct impact on Parish Councils mentioned)
- Cllrs. Davies and Andrew separate meetings with the 2 MPs over the impact of new Nursing Home on Salt Box site about getting better funding for the Wellbrook surgery. Only getting £8,000 p.a. extra funding for looking after the 66 bed home.

# > Cllr. Warriner (Church Broughton PC) Coach Park at Woodside Farm on Woodyard Lane.

The site was purchased in mid-2024 following sale of old Edgar Bentley Farmhouse and grounds. There have been a number of problems to date:

- 1. Coaches turning from and onto Woodyard Lane on the blind bend present a significant traffic hazard. A number of people have reported near misses. DCC Highways have been notified.
- 2. A fire was started on site on 30<sup>th</sup> October 24 producing black, noxious smoke fire brigade called and environmental complaint raised with DCC, investigated and now closed.
- 3. Felled tree stumps and wood brash have been dumped on Woodyard Lane from the site. A further environmental complaint has been raised (by SDCC Planning compliance).

# **Planning history**

The entirely separate transport site to the rear of the property was sold some years ago after planning consent for the wider Edgar Bentley farm in 2010. This has an appropriate entrance further South on Woodyard Lane. The farmhouse and farmyard at Woodside Farm (where the Coach Park is operating from) was included in the initial 2010 planning request but was rejected. One key reason appears to have been the problems with a proposed further "transport entrance" onto Woodyard Lane on a blind bend. SDDC Planning compliance team has raised Enforcement Notice ENF/2024/00191 having confirmed that the site doesn't have the necessary consents to operate a coach maintenance and parking business (Jaqueline Scott is the main point of contact via Jacqueline.Scott@southderbyshire.gov.uk).

2 of our 3 Ward councillors (Grahame Andrew and Jayne Davies) are both briefed and involved in the enforcement notice to date. Sundip Meghani is less involved.

A retrospective planning application is expected to be submitted in the next 4-6 weeks.

#### **Next steps**

CB PC will review the planning application when it arrives and circulate it around our Parish (as normal). We will determine if we wish to raise an objection ourselves. Some individual residents are likely to base on their experiences, views and statements to date.

A key action is likely to be to mobilise DCC Highways to review the application and the site's traffic risks. Our own experience is that DCC Highways won't always provide an input without encouragement. We will consider lobbying Charlotte Culpit directly and via our DCC Councillor (Julie Patten).

If F&S PC wish to object, and want to co-ordinate a response with CB PC, we'd be happy to discuss that further, to cover both the geographic location (in F&S) and the breadth of local residents being impacted (CB & F&S).
