Thank you for submitting your application to the **DVA Warm and Welcoming Spaces Grant**. The Grants Panel has now completed its review, and I am delighted to inform you that your application has been successful. You have been awarded **£1200**.

It transpires that a 2nd application for Warm Space Grant been made by a villager. Query projects applied for.

- Heating and lighting cost (15% of total usage) = £210
- Crafting materials, bingo tickets =£40
- Refreshments = £30
- Approx 10 x new large print novels (these are very hard to source second hand) = £90
- Replacement of the carpet. This is heavily stained and unpleasant aesthetically for young children to play on. The area 90 m sq at £6 per metre £540 plus £250 labour = £790

We don't have to give evidence of how the money is spent but the evaluation form asks for numbers of attendees, photos and a couple of case studies of activities.

The only overlap is heating.
