# **Report from District Councillor Julie Patten**

#### **Potholes:**

#### **Bolsover Recycling Centre:**

First re-use shop (Derbyshire) in partnership with HW Martins is open at Bolsover household waste recycling centre. The shop is open the same hours as the recycling centre, from 8.30am to 6pm.

# Car Thefts:

There has been a recent increase in car thefts in South Derbyshire, quite a few in Hilton. High performance cars are being targeted.

#### How to protect your keyless entry car

- When at home keep your car key (and the spare) well away from the car.
- Put the keys in a screened or signal-blocking pouch, such as a Faraday Bag and check if the bag or pouch is still working every few months.
- Reprogramme your keys if you buy a second hand car.
- Turn off wireless signals on your fob when it's not being used

# Highways Contact:

Does the Council have an inspector where Third Party Utility contractors have re-instated works. If the depth of works is 1.5 meters deep is there a two year repair time period required by the contractor. Both Leathersley Lane and Watery Lane had works carried out by Network Plus/Western Power nearly 2 years ago for relaying of electricity cables with a two year warranty on the road works. # Report from District Cllr Andrew and on behalf County Councillor Cllr. Davies.

- 1. The signs for Uttoxeter Road on Watery Lane and the entrance sign to Scropton had been removed for fixing by SDDC (Cllr Andrew to chase up timescales for re-instatement)
- 2. SDDC Planning had been chased regarding the PSED (Public Sector Equality Duty) statement relating to the Mill Green development
- 3. DMPA/2023/1494 Cllr Davies voted against the extension of the Solar Farm Planning Permission, however a majority of members of the Planning Committee did not, it has therefore been approved. Cllr. Davies commented that times have moved on and we would now build them higher and the fact that they haven't even built them yet is not a good start. At the time they were allowed through planning solar energy was a good way to produce energy, still is but as it is now the design would have been different and the councillors that voted it through before stated that they wouldn't have now.

#### Comments from Cllr. P. Groom.

With regards to this site and the development at HMP Foston Hall, the view is that SDDC Planners are not listening and there are no effective consultation when concerns are raised by the villagers and F&SPC have put in objections.

Councillor Davies commented that the original planning permission had already been approved and this was an extension from 30 to 40 years.

Section 73 of the 1990 Act provides for applications for planning permission to develop land without complying with previously imposed planning conditions.

Cllr. P. Groom very disappointed that although objections have been put to the council privately, no acknowledgment or response are received.

Cllr. G. Andrew to follow up.

4. Cllr Andrew advised that although later on the agenda he had already asked for the application by the Bottling Plant to erect a new 38m high warehouse next to the road, to be decided in front of Committee rather than an officer decision, having discussed the application at the Church Broughton Parish Council the week before.

I've already put in a request to call in planning application 1646 the bottling plant, following a request at the Church Broughton Council meeting.

#### **OPM090424/05** - Residents Correspondence

#### • Resident raised concern (via Facebook) that Scropton is being used by criminals to avoid ANPR cameras.

#### Police response:

*I can confirm there has been no reported Vehicle crime in Scropton, the only crime in Scropton during the last 6 weeks has been fuel theft from an HGV on the A50* 

If I could encourage residents and indeed councillors at the meeting to sign up to Derbyshire alert, they can hear direct from the local team who send out messages via email using the system with updates relating to any crime trends/ CCTV requests/ appeals and crime prevention etc. <u>https://www.derbyshirealert.co.uk/</u> I have cc'd your local team into this reply.

There certainly has not been an 'Epidemic' of car thefts in Scropton/Hatton or Hilton, the last report of vehicle crime in those areas was on 08<sup>th</sup> March-Hilton Theft from vehicle.

#### • Resident sent comment on play area refurbishment and its lack of access for disabled people.

Response from: Parks and Green Spaces Manager

Like most things it's a balance and the words "appropriate" "reasonable" and "proportionate" are the key things here.

The general equality duty is not specific about the approach a council should take.

Equality Impact Assessment should be undertaken for any major projects that materially change things...however how you define major is very much down to interpretation as in this instance it's just installing new equipment in an existing play area. If I recall a number of items of equipment are indeed inclusive. The available funding also has to be taken into consideration. New footpaths alone could be 10-20K. So in reality no improvements would have been made. The argument could therefore be made that it was totally reasonable to install the play equipment.

ElAs are not a legal requirement, but they serve as evidence of compliance with the equality act and Parish councils should consider the impact of their actions on equality and take steps to address any disparities.

The important thing is to document the Parish Councils decision making process so going forward it may be good for the parish council to have a policy which identifies how it looks at such things and also defines what a "major change" is form the parish councils' point of view. (From a district council point of view it could be changing the way we empty bins, or the closure of a facility.)

You are by no means unique, and many play areas, both in rural and urban locations, do not have good access so I would suggest that the best way forward is to have a plan on what you wish to do in an ideal world and then seek to make improvements where you can as funding pots come along. I am aware of new funding coming on stream later this year to help with this very issue for parish councils, so further improvements could be phased in.
