Comments from the Public:

Watery Lane, Scropton

- 1. Speeding vehicles still a problem / Parish Clerk to contact with Police.
- 2. Community speed watch can operate in 30mph. Discussion took place if the speed watch can operate in 40mph zones providing in safe areas.
- 3. Highways don't have a lot of records of incidences
- 4. 40 mph speed limit to be marked on road / Parish Clerk to report online to highways
- 5. Sign on side of road beware of Children playing/Dogs/Horses Parish Clerk to contact highways
- 6. Speed indicator sign Grant £65,000 but not sure what the grant is for. Can apply for up to 3, initial cost £2,500 to £3,000 each, plus licence fee, installation cost. Trial period 12 months. Further investigation required concerning the £65,000 grant.
- 7. Speed sign outside Scropton Riding School corrected showing correct speed limit / Parish Clerk to contact Highways
- 8. Delays on A50, Scropton used as a cut through with vehicle numbers increasing through village

Report from Cllr Peter Smith:

New Electric Charge points for Melbourne, Hilton, and Hatton

South Derbyshire takes another stride towards becoming a carbon neutral District with the installation of 24 more electric car charging points across three of the Council's car parks currently taking place and nearing completion.

The charge points are all being installed following successful bids for funding from the Office for Zero Emissions Vehicles.

The funding is aimed at providing residents with easily accessible charge points so they can recharge vehicles when they are at home. The additional benefit of having them in public car parks is that other people can use them when residents are not.

The Council now has 42 charge points to help with the transition to more electric vehicles in the fleet over the next decade.

Wildflower planting

Seed planting and the necessary preparatory works to the four pilot wildflower sites were completed across South Derbyshire last week in preparation for the summer by the Council's Grounds Maintenance Team.

Grass Cutting

The Grass Cutting Team are experiencing issues with a lack of available parts for the service and maintenance for the ride on mowers. This is not a major concern at present but if the supply issue is one to keep an eye on as it could impact on the mowing schedule during the summer months.

South Derbyshire CVS

Now have a Home Handy Person scheme to help those elderly or vulnerable people who live in SDDC owned property and need help with things like fitting light bulbs, locks, bolts, etc.

Support for Ukranian Guests

The government has changed the Homelessness Guidance to allow for Ukrainian Refugees to be dealt with by councils. The Housing Service has not had any direct approaches yet but is expecting this to happen shortly. The Environmental Health Team is undertaking assessments of properties of those who have volunteered to provide a home to Ukrainian families and is working closely with the County Council from a safeguarding perspective. More information will be produced regarding this shortly.

Unfortunately, there is a small but significant risk that organised crime gangs will use the scheme to entrap vulnerable Ukrainian families and so Council staff have offered to provide home safeguarding visits to local sponsors to check for evidence of any suspected ulterior motives.

It also gives the Council the opportunity to do a quick hazard check in the sponsor's home and to provide advice, support and access to resources to enable any sponsor to make their Ukrainian guests stay as safe and happy as possible.

The Team has been working at national level to develop processes for implementation across the UK.

Queens Jubilee SDDC Plans

The Events Team is busy planning the Queens Platinum Jubilee Celebration events which will take place across the summer in the District. Many existing events such as Liberation Day, Music in the Park and the Festival of Leisure will be Jubilee themed, and a further themed event is planned on the Band stand at Maurice Lea Park on 1 June. Local schools will be given the opportunity to have Jubilee trees planted and a visit and talk by the Chair of the Council and Beacon lighting events will take place at various locations on 2 June 2. Further information will be released in the coming weeks.

8. Derbyshire & Derby Minerals Local Plan – Proposed Draft Plan Drop-in Session held at Foston & Scropton Parish Hall, 6 April 2022 - From Derbyshire County Council

64 people attended over a 4-hour period from 2:30pm to 6:30pm. County Cllrs Julie Patten and Martyn Ford attended.

People in general were very concerned about the impact of the two proposed new quarries on the area, which has so far experienced no significant mineral extraction. A summary of the issues raised is set out below.

Traffic

Concern was expressed about the impact of quarry traffic on the local roads; on Leathersley Lane because of its narrow width and capacity to take such large vehicles and the fact it is part of the National Cycleway; and on the junction of the A515 with the A50. People raised the fact that the Sudbury roundabout is due to be upgraded by 2030 and how, while the work is being undertaken, this would impact on the quarry traffic. They asked whether this had been taken into account. People also raised the issue of the potential for quarry traffic to ignore the specified access route and travel through Sudbury and Scropton villages, particularly at times when the A50 is closed as a result of accidents. Many thought that road improvements would be essential to reduce the impact of the quarry, particularly by either widening Leathersley Lane or providing passing points and also improving the junctions with the A515 and A50.

Flooding

The issue of how a new quarry would affect flooding in an area already highly susceptible to flooding was a concern expressed by some people. The site proposed for extraction closest to Scropton is part of a floodwater holding area. It was considered by residents that the proposal for sand and gravel extraction would create a large area of open water, which would only further increase the risk of flooding in the area.

Noise and Dust

The impact of noise and dust from the guarries was raised as a concern.

Restoration

There was a lot of interest in what the restored sites would look like and the benefits that the restored sites would offer the community. People also expressed concern about the additional lorry movements that would be required to fill the Sudbury site. They also asked what it would be filled with.

Visual Impact

People that lived close to the site were particularly concerned about the visual impact of quarrying on their views.

Community Benefits

People asked whether the operators would be required to provide benefits to the local communities in terms of road improvements (particularly Leathersley Lane), village facilities etc.

Cumulative Impact

The cumulative impact of another industry operating in a rural area which is already the focus of major employers, such as Avara was raised as an issue. It was suggested that increasingly there seems to be more employment than people living in the area. Again, the issue of increased traffic passing through the village was raised in this respect.

Impact on House Prices

A number of people asked whether compensation would be provided to offset the likely reduction in market value of properties close to the guarries.

Other issues

• Some people were surprised that the two quarries would be operated separately even though they adjoin each other. They thought it would make more sense and be less disruptive if it was worked as one area with one processing plant and access.

- Related to this, it was requested that the plans of Foston and Sudbury be adjacent to each other in the next version so that people could more easily see that the sites are adjacent.
- Disappointment was expressed that Hanson and Cemex were not present to discuss their proposals.
- People expressed concern about the hours that the quarry would be open.

People were concerned about the level of information that was available at the local plan stage and were seeking more information about the sites more akin to the level of detail required for a planning application.

Discussion at Parish Meeting:-

9. Flooding Update

- We had the first Scropton Community Flood Group meeting Is month which was really successful. Notes are embedded in the flood update do.
- We meet again on 28th April where the EA will be attending to provide some education & background to the group.
- I have been liaising with Cllr Peter Smith, who will now be our Single Point of Contact for all things flooding.
- I will be attending the next flood liaison meeting. I have sent questions over to the group to review. Please add any additional questions you feel appropriate and I will submit prior to the meeting. This will hopefully ensure they are reviewed & responded to.
- MLP Consultation
- I have had lots of communication from residents on this, they have sent me copies of their objections to this. These include the following issues;
- Affect on local people noise, dust, traffic, pollution from increased HGV/ machinery, negative
 affect on house price, risks of damage to flood defences, destroying local character, safety (traffic),
 destruction of the 'village' environment, working hours 5.5.days per week unreasonable, loss of
 environment/ fields
- Traffic increase in HGV traffic is approx. 11,000% as to what it is today, Rd is unsuitable to upgrade rod would require significant works again compounding the issues for the local community, what happens when A50 closed already becomes dangerous and plagued with cars, increase in cars frm staff/ visitors/ maintenance, Rd has 7.5t restriction, A50 is a collision cluster already this poses a real danger at the Sudbury to uttox stretch,

- Environment destruction of agri land, is countryside location, flood risk, destruction of hedgerows
- Pollution massive volume of HGV just for Foston it will be 164 trips min per day, also machinery
 on site, use of fossil fuels for associated equip, noise no barriers fairly open with railway running
 through village which would carry noise from the industry, dust creation, waste production (more
 trucks), fumes from equipment & HGVs. Concern if being used as diversion route, which it regularly
 is, that there will much more traffic using the village increasing safety risk as well as pollution and
 character of village
- Wildlife total destruction for this area.

- I have arranged to meet with Cllrs from Sudbury 19th April to discuss our objections and pull together a more weighty joined up objection from both councils. Adding to the objection previously sent in 2020
