District Councillor Graham Andrew

On Behalf of myself and Cllr. Jayne Davies HMP Foston Hall and the 2 storey House Block planning application. Having read the Planners report, they've included the long list of objections from the parish council, 38 pages of the 119 page document is devoted to this one application. I didn't like the response from the developers about using the technicality that they are erecting secure accommodation, so they do not count as residential buildings where people are living. They also in the statement to the effect of the distances from other properties and overlooking issues are deemed to be acceptable. I'm not sure about the tree height around existing car park where the blocks are to be built. If it is above first floor level, and they may have a point, they are recommending approval of planning permission with a long set of conditions. Looking in the comprehensive set of documents, it is difficult to see that the members of the planning committee will refuse against the planning officers report. However, there are a lot of conditions that need to be satisfied prior to work commencing, so it may be some time before the work gets underway. A further recommendation the visual screening of the new building from existing homes,

Final development plans:

- Boundaries to have bushes, trees, balancing (attenuation) ponds, flora and fauna used to divide them.
- New countryside walks connecting Pennywaste wood to Heath Top, take ownership and maintaining for the benefit of residence.
- New bus route to the site that will be for all the factories inside in a timely manner for start and end of their shifts. Bus service to be paid for by Clowes Developments - meeting the companies as to how best a bus route coming in from Derby, Burton, Uttoxeter, picking up employees who are working on production line there
- Small area for development right in the centre of the site for an innovation centre for meeting, Development and learning with three offices and the boardroom that could be shared by tenants/employees.
